- **5. Remembrance Sunday Update** for information
 - Wrightington Parish Council have confirmed that Cllr Mike Grimes may lay a wreath on behalf of the Parish Council at the War Memorial at Appley Bridge on Remembrance Sunday.
 - The wreaths were collected last Tuesday and those that need to be distributed are in the process of being distributed.
 - Thanks to a donation via a resident, the Parish Council's supply of lamp post poppies has trebled. The Caretaker has been putting them up in Shevington Moor, Appley Bridge / Shevington Vale and central Shevington. The CVRA put up those in Crooke Village.

- The uniformed groups, the scout band, the bugler, the sound technicians with PA system and the Police have all confirmed their attendance.
- The Vicar has been contacted and has been in touch.
- Shevington Vale Primary School have let me know that their service will be on Friday, 10 November at 10:45am. I have passed this information on to Cllrs Jess Diggle and Mike Grimes.
- All proposed services/ceremonies have been announced in the newsletter currently being delivered to homes. Representatives more local to Shevington Moor and Crooke Village will circulate information in their areas nearer the time.
- The grounds maintenance team will do their best to have the Memorial Garden and Park
 as ready as it can be, but cannot promise to be able to mow the grass, as the ground
 conditions are poor. The hedge surrounding the Memorial Garden has recently been
 tidied up.
- Cllr Horridge will collect 'Our Tommy' from the Library and display him on the day.
- Shevington in Bloom will mount a display of knitted poppies on the day.

8. Planning for the Future of Wigan Borough to 2040 – the Wigan Borough Local Plan The Strategic Planning Team at Wigan Council have written:

"We are emailing as you have previously made representations on the Places for Everyone Plan or its predecessor, the Greater Manchester Spatial Framework.

At Wigan Council we are preparing a Local Plan that will sit under the strategic policy set out in the Places for Everyone Plan. This time last year, we consulted on Issues and Opportunities, and if you responded to that consultation this email will probably be a duplicate, for which we apologise.

We are now consulting on the Options and Preferences for the Local Plan, for 8 weeks until 23:59 on Monday 18th December 2023.

You can access the consultation online. It includes a main consultation document and an accompanying map book. On each you will be able to click on 'bubbles' in the page to both view comments that others have made and leave your own comments. It will be anonymous on the webpage.

You can also view paper versions of the documents in Wigan Council's libraries.

As part of the consultation, we are holding ten workshops which are an opportunity to discuss and debate matters in the Options and Preferences version of the Local Plan with the planners involved.

Each workshop will begin at 7pm with a short presentation (10 minutes) to set the scene, and then it will be about hearing everyone's views on those issues. There will also be the opportunity to raise anything else people want to. Each workshop will have a primary focus on the town concerned.

The workshops all begin at 7pm and are as follows:

Thursday 16 November: Standish Community Centre, Standish Wednesday 22 November: Golborne Parkside Club, Golborne
