SO 57. Interests

If a member has a personal, prejudicial or disclosable pecuniary interest as defined by the Code of Conduct adopted by the Council on 25/10/12 (change to 17/05/23) then he shall declare such interest as soon as it becomes apparent, disclosing the existence and nature of that interest as required.
