The library is currently being prepared to make it a Covid-secure environment with a view to opening as a library – possibly in mid-September.

## **Making Democracy Digital**

The Deputy Democratic Services Manager at Wigan Council recently joined a webinar on this topic and has shared the following points:

- Draft memorandum or code of conduct for virtual meetings is essential
- It takes approx. 3 members of staff at all large councils to run a virtual meeting
- Everyone is dreading Hybrid meetings and don't see how they will work
- ADSO is against hybrid meetings as they are of the view that they should be either face-to-face or virtual but not hybrid
- Teams meetings are getting a 'voting function' put in to assist public meetings this is in the pipeline
- Please refer to the LGA Remote Meeting Hub for tips and advice
- Lots of councils are similar to Wigan Council and are not ever going back to offices as they did before
- Town and Parish Councils don't want to go back to pre-Covid meetings
- ADSO and Councils are lobbying the Govt to allow legislation to continue post May 2021 for councils to continue to hold meetings virtually
- Virtual meetings allow more equality in politics a young mum can attend meetings from home and be an effective councillor as can a full-time worker who wouldn't have previously considered entering politics because of the demands of meetings.
- Some Leaders are doing Video Blogs now to engage with residents
- Online meetings have enhanced public engagement with committee meetings
- Meeting organisers and chairs need to ensure that they are not afraid to 'mute' a member when necessary
- GM 'Build Back Better' was mentioned and was suggested that it should be Build Back Greener homeworking is vastly improving our carbon footprint.
- Remote meetings are the way of the future LGA and ADSO fully support these.
- Councils have been extraordinary in how quickly they have adapted and responded digitally during this crisis.
