I am referring to the ones in Shevington Library. This is a building open to all so I cannot see any Health and Safety issues. All it requires is a sign (paper would be fine) advising Shevington residents that a toilet is available for use during opening hours. It may be these toilets are already available to the general public but if this true then the advertising is woeful.”
