- 6. Community Wellbeing Hub for information
 - Shevington Community and Recreation Centre (SCRC), which opened earlier in the year, is the result of over 10 years of Community involvement aimed at providing the people of Shevington Community with a place where they can improve their lifestyle. Recently, SCRC were approached by the Rugby League World Cup Organising Committee and the Rugby

Football League and invited to become involved in a pilot project to build on the relationship between the SCRC and the Community. A virtual meeting was arranged for 8 October with attendees from RFL, RFL World Cup, Wigan Council, My Life, Local Schools, Local Doctors and Patient Support Groups and Shevington Parish Council to investigate how the SCRC can be of greater use to the Community. The result of the well-attended meeting was the realisation of an exciting opportunity, led by the Community, with support from key experienced people from sport and activity sectors. These sectors work to use 'activities' of all kinds as a catalyst for sustainable and positive change to peoples' lives. The aim is to make the SCRC a "Community Wellbeing Hub" from where numerous 'activities' can be organised and led. The potential and opportunities are endless from: the pitches, the allotments, the building itself, the community, the walks and the varied associations surrounding and supporting the community. Further meetings are planned to begin to realise this potential.

Mr Charlie Neve attended the meeting on behalf of the Parish Council and wrote the above article, which has been published in the latest edition of the newsletter. He will expand on this in a verbal report.

7.
