On 20 October Wigan Cabinet agreed to trigger a statutory consultation over the closure of Shevington Miles Lane Community Primary School. Cllr Whiteley presented the case for keeping all three Federation schools open to the Leader and Deputy Leader of Wigan Council immediately before the Cabinet meeting. Her paper will be circulated for information.

441 Christmas Tree Stars – for consideration and agreement

During the Clerk's meeting with the representative from Blachere Illuminations one of the things discussed, as requested by the Council, was the provision of stars (similar in design to the one in use at Appley Bridge) for each of the other three trees. These stars will have to be bespoke, as the ones from the supplier of the Appley Bridge model are not designed for use with street lighting connections. The Clerk has received a quotation which compares well with the cost of a set of static LED lights for a tree of that height. The lights used for the stars are not static and can be expected to cost more. The stars can be made for use this Winter, but a decision will need to be taken at this meeting to allow enough manufacturing lead time for them to be delivered before the end of November.
