  - The Council have recently received a donation of £80 towards the costs of maintenance of the play area from the Friends of Shevington Memorial Park. This has been banked. The Council have also recently discovered that under the terms of the new SLA for the maintenance of the play area there will be a charge of £668.54 (payable in advance) for the four operational inspections and for the annual independent ROSPA inspection with risk assessment. In the light of this members are invited to approve the introduction of a 'Play Area Maintenance' cost centre to cover this in both this year's and next year's budget, as the new SLA begins on 1 April and the payment is required in advance. In both instances the funds will need to be vired from the General Reserve: (a) £588.54 w.r.t this year's budget and (b) £668.54 w.r.t. next year's budget.
