a) The family's preferred location is in the Memorial Garden, where Eddy liked to sit. They have said that, if the Committee agree to this location, they would like to have a bench identical to the four benches in the area around the War Memorial.



b) The family's alternative location is a spot beside the main footpath through the park, as this was the route that Eddy took on his way to Church every day. If this is the Committee's location of choice, they would like to have a bench like the wooden one installed last year beside the play area.
