Grant Funding for Memorial Park and the Woodland for consideration and agreement As agreed at the last Committee meeting, Mr B Lomas has carried out some research into funding streams for both the Shevington Memorial Park and the woodland projects. He has put forward the following as a preliminary report:
  - "If the process is to go ahead, a clear plan has to be swiftly arrived at. Then, it is suggested that the Parish Council should step back and receive feedback from those involved at different stages. Once the project is defined the Parish Council can only provide answers to specific questions; it would be counter productive to have long discussions and change ideas. A clarity of focus will be needed and complete faith in those completing the process. As with these things, success is not always the outcome.

Under the Heritage Lottery Fund there are several subsections.

There are two of particular interest:

1) Parks for People fund not-for-profit organisations for projects between £100k and £5 million.

At the time of application the project must be defined, should not have started and be complete within five years. The aim is to conserve the existing heritage and parks are named. The Parish Council will be expected to contribute between 5 and 10%.

DRAINAGE is specifically mentioned.

There is a project enquiry service with a 1000 word maximum single sheet outline opportunity to test the water.

It is important that we know exactly what we want to do.

**2)** Secondly, there is the **Landscape Partnership** that will fund projects of between £100k and £3 million which relate to landscapes and natural heritage, the aim being to improve, expand and connect threatened habitats. This is open to a similar outline as above and is suitable for the land recently purchased.

In addition there are a plethora of small bodies e.g. Biffa, Grimples Green Giants, Europa Nostra, that may be approached.

There is no doubt that the money is available but it would be an extensive task to furnish the information and inspiration will be needed.

This is the caution: a commitment of considerable time would be required and maybe up to twelve months to prepare a final bid (there are several rounds) with a very clear vision of the end product."

Members are invited to consider this and any further reports on the subject from Mr Lomas and agree the best way forward.
