The Feminist Review Trust was set up in 2001 with funding from the Feminist Review journal. Feminist Review is a peer reviewed, interdisciplinary journal setting new agendas for feminism. The journal is committed to exploring gender in its relationship to other axes of power including race, class and sexuality.

Individuals and organisations in the UK and internationally can apply for grants of up to £15,000 for projects including:

- Hard to fund projects. Some types of projects are difficult to fund. Typically
 these projects have no other obvious sources of funding. This might
 mean, for example, that traditional academic sources are either not

- Pump priming activities. This means that the Trust will provide a small amount
 of funding to help start an activity in the hope that it will then be able

- Interventionist projects which support feminist values. It is often difficult for projects around core feminist concerns such as abortion rights and domestic violence to find funding.
- Training and development projects: funding for projects which provide training in relevant areas.
- One off events: the Trust supported Cine25 as part of the celebrations of 25

years of Women's Studies at the University of York (UK); a seminar for the Lileth Project (a violence against women housing related project), and a workshop on the gender dimensions of Bulgarian Immigration Policy.

- Dissemination: the Trust will fund the production and distribution of relevant material. Too often work has had a more limited impact than it should because it was not well distributed.
- Core funding: the Trust realises that many groups struggle to raise core funding. The Trustees are willing to offer core funding to cover staff costs, accommodation etc.
- Other projects: the Trust may still support an application that does not easily fit into any of the above categories.

- providing better evidence of the effectiveness of the SIB mechanism and the savings that are being accrued

• growing the scale of the social investment market

TESCO BAGS OF HELP

Tesco offers grants through its Bags of Help Programme which is funded by Tesco customers from the proceeds of the 5p charge for plastic carrier bags as a result of a government carrier bag levy.

Each month, an in-store vote will determine which projects will be funded. Three local community projects will be voted on in Tesco stores each month across 200 regions throughout Great Britain. In each region, the project that received the most votes from all

stores in their region will receive a grant of up to £5,000.

The second placed project receives up to £2,000 and third placed up to £1,000. Every year, over 7,000 projects will receive funding through this scheme.

The funding is for projects which deliver improvements to the physical environment and/or encourage the use and long term stability of outdoor spaces.

Examples include:

- Developing nature trails in a local park or nature reserve.
- Purchasing bee hives and seeding wildflower meadows on a community allotment.
- Providing forest school sessions in a primary school for 12 months.
- Developing a garden in a hospice, purchasing plants, benches and pergola.
- Supporting an artist in residence to work with the community to develop an art trail.
- Setting up a growing project for sheltered accommodation residents.
- Supporting a gardening project which helps local isolated residents form a gardening club.
- Supporting practical training for young people learning horticultural skills.
- Funding a series of summer events in a local park.
- Funding a programme of beach clean-up events.
- Repainting swings and play equipment in a park.
- Supporting community run summer sports and leisure activities in parks.
- Helping to set up Britain in Bloom local group, purchasing plants, planters, forks, spades and compost.
- Developing a community garden or orchard.
- Supporting local football club with the purchase of nets, balls and coaching sessions for under 12's.

A range of not-for-profit organisations can apply. Aims/Priorities: Works to freestanding war memorials in England are eligible for support through the Grants for War Memorials funded by English Heritage and The Wolfson Foundation. War Memorials Trust seeks to help all war memorial custodians, whatever the nature and size of their war memorial by facilitating repair and conservation projects. Grant amount: Grants are currently available up to 75% of eligible costs with a normal maximum grant of £30,000. Depending on the cost of your project you will have different requirements in relation to obtaining quotes/tenders. Grants can start from as little as £50 and have been above £30,000 in exceptional cases where substantial projects have been undertaken.
